## Climate Solutions Resource Guide



Greenburgh is one of just ten communities selected out of hundreds of participants nationwide to host a Spotlight Conversation on Climate Action at the Greenburgh Library on Earth Day, 22 April 2009. This guide has been prepared as part of this national conversation. It contains detailed biographies of the event's speakers and moderators, a listing of the Climate Plan Action Committee, and useful web sites.

Paul Feiner has served as Supervisor for the Town of Greenburgh since 1991. He was a member of the Westchester County Board of Legislators from 1983 to 1991. Before running for public office, Mr. Feiner worked to establish the Bike-It Sunday program on the Bronx River Parkway, and start a commuter bus service from Scarsdale to Manhattan. As an elected official, he has championed issues from banning pesticides on town property to using solar energy to partially heat the Town Hall building. During his tenure as Town Supervisor, Mr. Feiner started a farmer's market; initiated a summer jazz concert series; opened an animal shelter, increased the amount of open space from 200 to more than 600 acres; and acquired three major parks: Harts Brook Nature Preserve, Glenville Woods, and Taxter Ridge. Mr. Feiner's unique Town Board meetings are widely recognized as models of good government. Among his many achievements were the initiation of a new concept called Dial Democracy, where residents have tele-phone access to Town Board meetings in progress. Under his leadership, Greenburgh was named one of the 100 best places to live by Money Magazine in 2008.

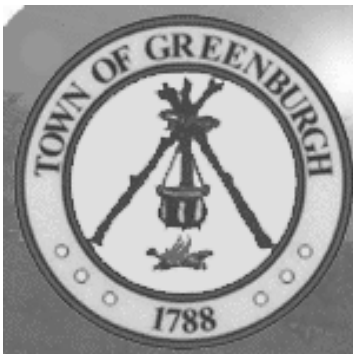

## **GNC Brings Villages, Town & County Together on Environmental Planning – September 2008**

### **GREENBURGH ENVIRONMENTAL FORUM**

During the winter and spring of 2008, meetings were convened at the Greenburgh Nature Center bringing together representatives of the CAC's/ECB's/CAB's of the six villages and unincorporated Greenburgh to discuss shared environmental issues. It was immediately clear to all that such meetings have tremendous potential for information sharing and laying the foundation for cooperation on environmental issues that cross municipal boundaries. While recycling was the first issue on which the meetings focused, other issues of shared concern were identified. These included: open space and wetlands protections, water quality protection, stormwater management, flood mitigation, energy conservation, and transportation.

With environmental challenges intensifying and becoming increasingly costly at a local level, regular inter-municipal discussion is crucial both to ensure that neighboring communities are not working at cross purposes and to maximize opportunities for mutual support and cooperative action. In applying for County and State support as well as in the battle to win over public opinion, the municipalities of Greenburgh can benefit tremendously by working on environmental problems together.

In order to build upon the communication initiated at the GNC over the last six months, in August 2008, the Greenburgh Nature Center invited each of the mayors and unincorporated Greenburgh to appoint a citizen volunteer with appropriate environmental involvement to represent their municipality in the Greenburgh Environmental Forum (GEF). The purpose of the GEF is to facilitate steady, focused communication between the villages, the Town of Greenburgh, and Westchester County government on shared environmental issues. The Forum meets monthly at the GNC. Some issues currently under study by the GEF include stormwater management/flood risk reduction; protecting the environment through the planning process and zoning codes; solid waste reduction and recycling, and transportation.
