# SUMMERTIME

**O**f course, practically everybody wants to head across the pond in July for the 2012 Summer Olympic Games in London, but for those of us staying stateside, there's plenty of easy breezy things to enjoy throughout the summer season in and around the Tri-State area. According to the New York State Office of Parks, Recreation & Historic Preservation, 178 state parks from the shores of Long Island to Niagara Falls offer countless opportunities, including adventurous explorations, beaches, boats, campsites, hiking trails and golf courses. The city further offers a full range of warm-weather events (most of them outdoors), including Manhattan's Shakespeare in the Park (*As You Like It*, June 5 to 30; *Into the Woods*, July 23 to August 25), Macy's Fourth of July Fireworks celebration on the Hudson River, the Museum Mile Festival from 82nd to 105th Streets on Fifth Avenue (June 12) and the U.S. Open Tennis Championships (August 27 to September 9) in Queens.

Naturally, al fresco dining at hipster-haunt restaurants is a must around town as well, especially during NYC Restaurant Week (July 18 to August 10) and the Hudson Restaurant Week (July 23 to August 3) along New Jersey's Gold Coast, including eateries in Hoboken, Jersey City, Weehawken and Liberty State Park. And don't forget, summer is the ideal time for farmers markets and roadside stands selling locally grown vegetables and fruits, with favorites such as beefsteak tomatoes, corn and sweet-as-pie peaches.

## ISLAND FEVER

With flip flops, bathing suits and sunglasses in tow, aquatic pleasures are pretty easy to find along the summer landscapes of the Hamptons' beach towns — and it's pretty much a given that both visitors and locals will enjoy any one of the Hamptons'

events and festivals. One good example is the annual Mercedes-Benz Polo Challenge (July 21 through August 25) in Bridgehampton. A red-carpet event (read: celebrity and royalty magnet), the Challenge runs six consecutive Saturdays. Another must-attend event is the free Amagansett Fine Arts Festival (July 6 to July 8). This three-day festival attracts some of our nation's best artists who exhibit their paintings, photographs, sculptures and the like. Kid-friendly to the max is Westhampton's Broadway by the Beach Camp (July 16 to July 20) for seven- to 10-year-olds. This weeklong camp is designed to teach kids singing, dancing and acting — as they prepare for an end-of-camp musical performance. Adventureland (an amusement park celebrating its 50th birthday) in Farmingdale is yet another fun way to spend a summer day.

Amagansett art lovers who wouldn't mind living within walking distance of the Amagansett Fine Arts Festival should take a look at what famed architect James D'Auria designed as his own home. Off Old Stone Highway near Main Street in North Amagansett,

this 4,800-square-foot, three-bedroom house with an open plan begins with a long tree-lined driveway leading to the front door. In-home highlights include a two-story living room framed by clearstory windows, four working fireplaces, a large chef's kitchen and a separate studio at the far end of the backyard's lush lawns, gardens and wildflower-planted meadow. Exclusively listed with New York-based Halstead Property, this home is priced at \$5.995 million. Occupancy is immediate.

A 16,000-square-foot estate at 66 Seafield Lane, Westhampton Beach South, overlooking Quantuck Bay, is also for sale. Built on more than 10 acres with 1,000 feet of water frontage and originally designed in 1903 by architect Henry Bacon (best known for designing the Lincoln Memorial in Washington D.C.), this complex boasts a nine-bedroom main house with six fireplaces, two large living room areas, a banquet-sized dining room with hand-painted murals, a billiards room, a sunroom, a home office and a large gourmet kitchen with breakfast area.

Additional features are a carriage house and separate cottage. Warm-weather venues include formal gardens and rolling lawns, a greenhouse, a tennis court, a gunite pool and a deep-water dock for sail-aways, whether impulsive or well-planned. Exclusively listed with Prudential Douglas Elliman, this property is priced at \$24.75 million and ready to welcome you home.

For other South Fork-bound estate buyers, check out Chateau Amorois, set on more than eight acres south of the highway in East Hampton. Designed by renowned architect Boris Baranovich, this gated estate is surrounded by lush grounds replete with verdant lawns, gardens, allées (walkways framed by trees or tall shrubs) and a man-made lotus pond. Included in the 9,000-square-foot manor are five bedrooms plus staff quarters, a large living room, a formal dining room with a fireplace and a master bedroom with working fireplace. Topping the list of at-home summer fun is a swimming pool in front of a huge bathhouse, a tennis court and a barn. Listed exclusively with New York-based Brown Harris Stevens and ready for a summertime move in, this home is priced at \$28.5 million.

Some 65 miles from the Hamptons and less than 25 miles from Manhattan is the long-established waterside Village of Sands Point in Nassau County. Set along the Long Island Sound and covering 3,000 acres at the tip of the Port Washington Peninsula, about 850 people call this village home. Made up of single-family homes only with no allowances for partial rentals, the village attracts buyers with its nature preserve, private golf club and yacht club.

Located at Boulder Beach in Sands Point, a waterfront estate built in 1930 on nearly three

acres is now on the market. ### SUMMER IN THE CITY

Filled with one-of-a-kind lighting fixtures, radiant heat floors, stainless steel and glass staircases, and an Elan system for controlling audio/visuals, temperature and light, the townhouse also has a perfect-for-entertaining open Boffi kitchen, dining area and living room. As an added bonus, a half basketball court converts to a movie theater at the drop of a hat.
