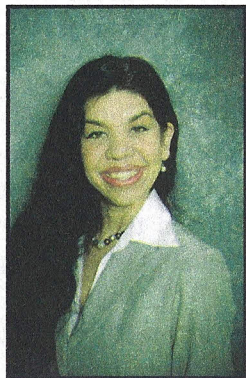


# Sultana L. Haque
